Reading Foundations

Reading Comprehension

RC. Students comprehend grade-level text, including fiction and nonfiction, and can demonstrate their comprehension orally and through writing. 5.RC

1. Quote accurately from a text when explaining what a text says explicitly and when drawing inferences from the text. (E) 5.RC.1
 2. Determine the theme of a story, play, or poem from details in the text, including how characters respond to challenges or how the speaker in a poem reflects upon a topic; summarize the text. (E) 5.RC.2
 3. Describe two or more characters, settings, or events in a story or play, drawing on specific details in the text and how they impact the plot. 5.RC.3
 4. Describe how a narrator's or speaker's point of view influences how events are portrayed. 5.RC.4
 5. Compare and contrast stories in the same genre on their approaches to similar themes and topics. 5.RC.5
 6. Determine two or more main ideas of a text and explain how they are supported by key details; summarize the text. (E) 5.RC.6

1. Write persuasive compositions in a variety of forms that: 5.W.1
 - a. Clearly present a position in an introductory statement to an identified audience. 5.W.1.A
 - b. Support the position with qualitative and quantitative facts and details from various sources, including texts. 5.W.1.B
 - c. Use an organizational structure to group related ideas that support the purpose. 5.W.1.C
 - d. Use language appropriate for the identified audience. 5.W.1.D
 - e. Connect reasons to the position using words, phrases, and clauses. 5.W.1.E
 - f. Provide a concluding statement or section related to the position presented. (E) 5.W.1.F
2. Write informative compositions on a variety of topics that: 5.W.2
 - a. Introduce a topic; organize sentences and paragraphs logically, using an organizational form that suits the topic. 5.W.2.A
