Developing Skilled Readers and Building Reading Stamina **DSR**

- 1 The student will build knowledge and comprehension skills from reading a range of challenging, content-rich texts. This includes fluently reading and gathering evidence from grade-level complex texts, reading widely on topics to gain purposeful knowledge and vocabulary, and using reading strategies when comprehension breaks down. **11.DSR.1****
 - A** Read a variety of grade-level complex texts with accuracy, automaticity, appropriate rate, and meaningful expression in successive readings to support comprehension. Monitor while reading to confirm or self-correct word recognition and understanding, as necessary (Reading Fluency, K-12). **11.DSR.1.A**
 - B** Proficiently read and comprehend a variety of literary and informational texts that exhibit complexity at the lower range of the grades 11-12 band to generate and respond logically to literal, inferential, evaluative, synthesizing, and critical thinking questions (See the Quantitative and Qualitative Analysis charts for determining complexity in the Appendix.)  - C** When responding to text through discussions and/or writing, draw several pieces of evidence from grade-level complex texts to support claims, conclusions, and inferences, including quoting or paraphrasing from texts accurately and tracing where relevant evidence is located (Textual Evidence, K-12).V **11.DSR.1.C**
 - D** Regularly engage in reading a series of conceptually related texts organized around topics of study to build knowledge and vocabulary (These texts should be at a range of complexity levels so students can read the texts independently, with peers, or with modest support.). Use this background knowledge as context for new learning (Deep Reading on Topics to Build Knowledge and Vocabulary, K-12). **11.DSR.1.D**
 - E** Use reading strategies as needed to aid and monitor comprehension when encountering challenging sections of text. These sense-making strategies attend to text structure, common organizational structures, summarizing, asking questions of the text, and others (Reading Strategies, 3-12). **11.DSR.1E**

Reading Literary Text RL

RL. The student will use textual evidence to demonstrate comprehension and build knowledge from a variety of grade-level complex literary texts read to include literary nonfiction (including world, British, and American literature), narratives, poetry, and drama, with an emphasis on American literature. 11.RL

1 Key Ideas and Plot Details 11.RL.1

- A Analyze the development of universal themes (e.g., loss of innocence, coming of age, relationship with nature) prevalent in American literature (e.g., short stories, poems, plays, novels, essays, and literary nonfiction) of different eras. 11.RL.1.A

Writing W

W. The student will write in a variety of forms for diverse audiences and purposes linked to grade eleven content and text with an emphasis on argumentative and analytical writing. 11.W

1 Modes and Purposes for Writing 11.W.1

- A Write extended pieces that: 11.W.1.A
 - i Introduce a topic clearly by providing context, presenting well-defined theses, and previewing what follows. 11.W.1.A.I
 - ii Adopt an organizational structure that clarifies relationships among ideas and concepts. 11.W.1.A.II
 - iii Develop the topic through sustained use of the most significant and relevant facts, concrete details, quotations, or other information from multiple authoritative sources appropriate to the audience's knowledge. 11.W.1.A.III
 - iv Provide a concluding section that follows from the information or explanation presented. 11.W.1.A.IV
- B Write analyses that: 11.W.1.B
 - i Develop a thesis that demonstrates knowledgeable judgments. 11.W.1.B.I
 - ii Interpret and investigate evidence from various sources and texts to draw reasonable conclusions that support the writer's position or assertion. 11.W.1.B.II
 - iii Examine and evaluate processes and/or problems to propose solutions. 11.W.1.B.III
 - iv Organize claims, counterclaims, and evidence in a sustained and logical sequence that explains how the credible evidence supports well-defined points of view. 11.W.1.B.IV
- C Write to describe personal qualifications for potential occupational or educational opportunities, producing clear and coherent writing in which the development, organization, and style match the intended audience and purpose of the workplace and/or post-secondary education and language in informal and formal contexts. 11.W.1.C
